

POWER BUTTON: Switch Device ON/OFF

SOUND SWITCH: When pressing this button, the detector is switched with the loudest sound playing first. The switch sequence is as follows: The loudest sound first, then no sound, and finally normal sound.



MODE SWITCH: The detector is switched on with the default unit being "mm" and can switch between millimeters and inches by pressing this button.

The detector is switched on with NO background light. Hold this key for 3-4 seconds to turn on the light. The screen will illuminate with a white light.



ACCURACY SWITCH: The detector is switched on with the default accuracy, starting at the highest accuracy. The sequence of the switch is high accuracy, middle accuracy, rough accuracy.




