Assembly Instructions

TOOLS REQUIRED (BUT NOT INCLUDED):

Drill Bit
Drill

Pencil
Wrench

Philips Head
Screwdriver

STEP 1:

1. Remove all the parts and hardware from the packaging and ensure you have everything.

STEP 2:

1. Locate the Bubbler Tap (B), Small Washer (7), the Fixing Nut (8), and the Basin (A).
2. Connect the Bubbler Tap (B) to the Basin (A) by placing your Small Washer (7) and the Fixing Nut (8) directly underneath the Bubbler Tap (B) by screwing the Locknut in place.
3. Ensure they are tight and facing the right direction.

STEP 3:

1. Locate a spot on the wall and mark where you will drill your 7 holes.
2. Drill 3 holes for the Mounting Plate (I), place your plate over the holes, insert three Plastic Anchors (2) and screw in three Tapping Screws (3).
3. Insert the four Expansion Screws (1) into their respective holes, as pictured, and secure them in place.
4. Adhere the Basin (A) to the wall by sliding it down until the Mounting Plate (I) catches.

STEP 4:

1. Next, locate the Large Washer (9), Basket Strainer (10), O-Ring (11), Tail Pipe (E), the P-trap (F), the Trap Assembly (G), and the Drain Pipe (H).
2. Connect the P-trap (F) to the Trap Assembly (G) and then the Tail Pipe (E), as shown, by hand.
3. Once they're assembled, connect the Trap Assembly (G) to the Drain Pipe (H) and then insert the O-Ring (11) on the top of the Tail Pipe (E).
4. Twist on your Basket Strainer (10) and place the Large Washer (9) in the Basket Strainer (10) and affix to the Basin (A) as shown.

STEP 5:

1. Connect the Water Supply Connections (2) from the Bubbler Tap (B) to the Inlet Hose (3).
2. Turn on your water supply to check for any leaks.

STEP 6:

1. Now it's time to check the stream height from the Bubbler Tap (B).
2. The stream height is factory set at 6 cm – 6.5 cm. if the stream height varies greatly, take the Locknut (C) off using a flat head screwdriver by turning it counter-clockwise.
3. Insert the screwdrivers into the two grooves in the Bubbler Tap (B).
4. Slightly turn it counterclockwise and screw the Lock (F) back on and test the stream.

Limited Warranty

1. Alpine Industries (the company) warrants to the purchaser that the product will be free from defects in workmanship and materials for a period of one (1) year from the date of purchase.
2. These warranties are not assignable or transferable to any other person.
3. Any damage to the product as a result of misuse, tampering, abuse, neglect, accident, improper installation, modification, unauthorized service, destruction, or the alteration of the serial number or use violates of the instructions furnished by the Company will void this warranty.
4. The sole responsibility of the Company shall be limited to the repair or replacement (in its sole discretion) of any component of the product which fails to conform to this warranty at no cost to the purchaser for the period of the warranty.
5. Contact the Company directly to obtain service under this warranty. If it becomes applicable to send a defective product to the Company, a Return Authorization Number must first be obtained from the company. In order to obtain service under this warranty, purchaser must provide the Company with the following items (a) proof of purchase, (b) police or fire department report, (c) photographs of damaged sad, and (d) written testimonial.
6. Products shipped without prior Return Authorization and Return Authorization Number may not be accepted, and the Company will not be responsible for their disposition and/or cost of return to the owner.
7. The Company will not assume any responsibility for any loss or damage incurred in shipping. All return authorized products should include a copy of the original invoice in order that this warranty may be Honored.
8. This warranty is not an insurance policy. The Company is not responsible for any manner of damage to or theft of the Purchaser's product or its contents.
9. We recommend that the product being returned is accompanied by the sales receipt with all relevant information regarding the purchase of the item and is returned to the Company within ten (10) days of the claim date of purchase to validate this warranty.
10. Any implied warranties that the purchaser may have are limited to the duration of the warranties described above. There are no further warranties that extend or apply beyond the face hereof, and the company expressly disclaims and excludes any and all warranties of merchantability or fitness for a particular purpose.
